Welcome to Woodland Prairie, home of the pumas! Woodland Prairie has a 31-year history of serving children and families in Woodland. We believe in the power of strong partnerships between families and the school, and we look forward to building those connections with our students and all the adults who help to make them successful.

Prairie continues to offer early childhood education onsite as well as comprehensive Kindergarten through sixth grade. The campus houses 2 distinct preschool programs, which allows us to find the best match between program and family need. For older students, we offer a strong academic program with two distinct strands that run from Kindergarten through sixth grade. One strand is a Spanish/English Dual Immersion program for families who wish for their children to become literate in both Spanish and English. The other strand is an English Language Mainstream strand that provides students with excellent preparation for middle school through English language development and strong content area instruction.

We are proud to serve our families, especially during this time that is so complicated for families and institutions alike. We deeply appreciate the support they show us every day.

Woodland Prairie Elementary School operates on a traditional academic calendar, and during the 2019-20 school year, 788 students were enrolled in from preschool through grade six. Woodland Joint Unified School District includes seven preschools, eleven elementary schools, one charter elementary school, two middle schools, two comprehensive senior high schools, a continuation high school, and an adult school, and served approximately 9,636 students in the 2019-20 school year.

Woodland Prairie Elementary School, originally constructed in 1986, offers a safe and secure campus for students, staff, and visitors. The school is currently comprised of 23 classrooms, one library, one multipurpose room, one staff room, and two playgrounds, one computer lab, and two triple wide buildings for a Special Day Class Preschool. Facility information is current as of October 29, 2020.

Cleaning Process

The Principal works daily with the custodial staff to ensure regular and continual maintenance of the school's physical environment.

Opportunities for Parental Involvement

Here at Woodland Prairie we believe our school works better because of the partnerships we form with families and the surrounding community. We know that parent involvement comes as early as the conversations parents have with their children about education before they even start in one of our preschools. We also know that parent involvement comes in many different forms and changes as students grow and develop across their school careers.

We offer several ways for families to get involved with their children's education here at Prairie. All meetings and events are conducted using computer-based meeting software. That being said, anyone in our school community can become a member of one of our parent groups such as the Parent Teacher Association (PTA) or the English Learner Advisory Council (ELAC). Both groups offer opportunities for volunteering as well as opportunities to take classes or training. If you are interested in working on policy or budgeting, you may be more interested in joining our School Site Council. Even if you are not able to attend these events, you can stay involved by checking our website, registering for the AERIES parent portal and making sure we have your correct contact information so that you receive our weekly phone calls.

The Prairie Elementary administrative team and school staff also regard student involvement and leadership development as a critical piece of a wellrounded education. Seeking out and responding to student voice around current issues faced by youth at the school as well as in the community at large is an ongoing effort at Prairie, and students are provided typical vehicles for participation such as acting as a Student Council officer or class representative or participating in the ASES (After School Education and Safety) Continuous Quality Improvement process. In addition to these possibilities, Prairie students are being asked to participate in surveys across the year to gauge their feelings about the socio-emotional climate on campus and being recruited for focus groups and input committees. Target groups for this year's input committees include students who receive special education services and newcomer students. The administrative team will work with the school counselor and teachers and staff across the year to identify other groups of students who can provide this type of valuable input and direction in terms of improving school culture for all students who attend Prairie.

School Safety Plan

Safety of students is a priority of the school staff. School staff address safety concerns such as student supervision and the traffic patterns of vehicles entering and exiting campus.

Woodland Prairie Elementary School's Site Safety Plan is typically reviewed each fall by the School Site Council, which consists of administrators, teachers, counselors, classified staff, and parents. The former plan was last reviewed by the Prairie School Site Council in January 2020. The current plan has been adjusted to address new security issues and continues to be expanded in order to comply with new District, County, State and Federal safety regulations. School Site Council will review and adopt the plan formally in January 2021.

The school is in compliance with all laws, rules, and regulations pertaining to hazardous materials and State earthquake standards. Emergency drills are conducted on a regular basis throughout the school year, including monthly fire evacuations and annual disaster and intruder drills. In the event of an emergency, the school's Disaster Preparedness Plan has clearly defined procedures to accommodate crisis situations, and emergency supplies are available.

Woodland Joint Unified School District provides time and resources for collaboration, planning, and professional development for all staff. Teachers at each school receive training directly related to curriculum and instruction by attending workshops and conferences that are approved by the district and administration. Staff development days enable staff members to deliver curriculum and instruction that is rigorous, challenging, and responsive to student needs. The development of a common district-wide instructional focus is allowing entry point for everyone to learn and stretch their practice. The focus of professional development has shifted to provide job-embedded coaching across multiple content areas to build capacity and focus on strengthening application of instructional strategies.

Woodland Joint Unified School District uses a variety of professional learning models to engage staff in their continued growth. During the school year and summer, staff have opportunities to complete professional development learning episodes and time to implement best practices learned. The professional growth occurring in Woodland Joint Unified School District has a heavy emphasis on collaboration with time reserved weekly for staff collaboration by sites in grade level or departmental teams under the direction of site administrators.
